D. Tax Refunds

1. Refund of 2009-10 taxes made in the amount of \$4,898.96, payable to Herman Katz & Cangemi LLP, attorneys for the petitioner, Coca-Cola Enterprise, Inc., 38 Warehouse Row, Tax Map #41.20-1-10. Property was improperly assessed, and refund is in compliance with a June 2, 2010 Supreme Court decision. Refund is made without interest.

1. A preliminary contract with the Board of Cooperative Services of Albany-Schoharie-Schenectady-Saratoga Counties for the 2010-11 school year totaling \$2,486,939.74.
2. An amended contract with the Board of Cooperative Services of Albany-Schoharie-Schenectady-Saratoga Counties for the 2009-10 school year totaling \$2,888,599.83.
3. A contract with the Colonie Youth Center, Inc. for the social work services of three (3) full-time consultants in an amount not to exceed \$188,569.00. The term of the contract shall be September 1, 2010 through June 30, 2011.
4. A contract with Wildwood Programs to provide educational services to six (6) South Colonie resident students for July/August 2010 at the interim rate of \$7,231.00 per student.

5. Agreement between Joan Martelle, PT, and South Colonie Central Schools to provide physical therapy services to a special education student in accordance with the recommendations and goals set forth in his 2010-11 IEP. Service will be conducted at his home or in the community as determined appropriate by the therapist and family. The fee shall be \$55.00 per 30-minute session and includes actual time preparing for session, direct service, and completion of progress notes. Session notes shall be completed for each session and will be submitted at the end of each quarter along with a quarterly progress summary.
6. Contracts with St. Catherine's Center for Children to provide educational services for South Colonie School District students placed with that Agency. Tuition costs for the summer session 2010 shall be \$2,808.00 per month. Tuition costs for the 2010-11 school year shall be \$3,444.30 per month. In the event a child is enrolled at a time after September, such tuition shall be charged on a per diem basis during the first month of enrollment and monthly thereafter.
7. Agreement between Advanced Therapy, One Rapp Road, Albany NY 12203 and South Colonie Central Schools to provide physical therapy services for twelve (12) hours per week at the total rate of \$3,000.00 during the 2010 summer session starting the week of July 12, 2010 and ending August 13, 2010.
8. A contract between Crossroads Center for Children, Inc., 105 Lakehill Road, Suite 4, Burnt Hills, NY 12027, and South Colonie Central Schools to provide Special Education services for two (2) South Colonie students from July 12 to August 20, 2010.
9. A contract with Four Winds Saratoga, 30 Crescent Avenue, Saratoga Springs, NY 12866, to provide tutorial services for South Colonie students at a cost of \$28.00 per hour for instruction according to the following schedule: Ten (10) hours per week for middle and high school students and five (5) hours per week for elementary school students.

The Board of Education of South Colonie Central School District, Albany County, New York, HEREBY GIVES NOTICE that a special district meeting of the qualified voters of said School District will be held at the places hereinafter set forth on the 13th day of October 2010, at 11:00 o'clock A.M., Prevailing Time, for the purpose of voting by machine upon the proposition hereinafter set forth. Polls for the purpose of voting will be kept open between the hours of 11:00 o'clock A.M. and 9:00 o'clock P.M., Prevailing Time.

Proposition

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of South Colonie Central School District, Albany County, New York, is hereby authorized to purchase buses, at a maximum estimated cost of **\$634,200**; and that such sum, or so much thereof as shall be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District shall be issued.

NOTICE IS HEREBY FURTHER GIVEN that the aforesaid proposition will appear on the ballot labels of the voting machines used at such special district meeting in the following abbreviated form:

ABBREVIATED FORM OF PROPOSITION

Shall the proposition set forth in the notice of this meeting authorizing the purchase of buses, at a maximum estimated cost of **\$634,200**; and providing that such sum, or so much thereof as shall be necessary, shall be raised by a tax levy to be collected in annual installments, with District obligations to be issued in anticipation thereof, be approved?

NOTICE IS ALSO HEREBY GIVEN that absentee ballots shall be made available in accordance with the provisions of Section 2018-a of the Education Law and that applications for such absentee ballots may be applied for at the office of the School District Clerk no earlier than thirty days prior to the vote. Any such application must be received by the District Clerk at least seven days before the date of the aforesaid Special District Meeting if the ballot is to be mailed to the applicant, or the day before such Special District Meeting, if the ballot is to be delivered personally to the applicant.

NOTICE IS FURTHER GIVEN that the Board of Education shall make a list of all persons to whom absentee voter's ballots shall have been issued and such list shall be filed in the office of the School District Clerk where it shall be available for public inspection during regular office hours until the date of the aforesaid Special District Meeting. In addition, such list shall also be posted in a conspicuous place or places during the hours of such Special District Meeting, and any qualified voter may challenge the acceptance of the absentee voter's ballot of any person on such list by making his or her challenge and the reasons therefore known to the inspectors of election before the close of the polls.
